Maternal Exposures Data Collection Overview

Purpose

• The purpose of this data collection is to improve healthcare for newborns exposed by focusing on treatment and length of stay in the hospital. Using the CPQCC database and partnering with the community of neonatologists and pediatricians committed to improving the quality of care in California, we have a unique opportunity to collect data about the variations in practice and important associates with the outcome of infants that have been exposed inutero.



Maternal Exposures Data Collection Overview

Eligibility

- Any infant greater than or equal to 34 weeks gestation with an **in-utero** history of exposure to opioids/narcotics (prescribed or illicit) with Neonatal Abstinence Syndrome (NAS) withdrawal symptoms by Day of Life 7. See list of drugs for complete eligibility:
 - Buprenorphine (Subutex, Suboxone)
 - Codeine
 - Fentanyl
 - Heroin
 - Hydrocodone
 - Hydromorphone
 - Methadone
 - Oxycodone
 - Other



Hospital Quality Improvement Collaborative

Goals:

- Work with hospitals in the identified counties around perinatal substance exposure, with an emphasis on opioids
- Improve the care and outcomes for both mothers and their newborns
- Maintain the mother-baby dyad
- Help make connections prenatally and after discharge, so mother and baby access wraparound services and continued support



QI Collaborative

During the 12-month Quality Improvement Collaborative:

- Access to the toolkit and implementation guide
- Support with implementation from a mentor team consisting of an expert in maternal care and an expert in newborn care
- Sharing of learnings with other collaborative-participating hospitals
- Access to Technical Assistance
- Near real-time data in the CMQCC Maternal Data Center to work on Quality Improvement
- Participation is free



Mother & Baby Substance Exposure Initiative: Collaborative Measures

Outcome Measures

Average length of stay for newborns with Neonatal Abstinence Syndrome (NAS)

Structure Measures

Has your hospital implemented a universal screening protocol for OUD?

Has your hospital implemented post-delivery and discharge pain management prescribing practices for routine vaginal and cesarean birth focused on limiting opioid prescriptions?

Has your hospital implemented specific pain management and opioid prescribing guidelines for OUD patients?

Mother & Baby Substance Exposure Initiative: Collaborative Measures

Process Measures

Percent of affiliated prenatal care sites which have implemented a universal screening protocol for OUD

Percent of women with OUD during pregnancy who receive MAT or behavioral health treatment

Percent of women with OUD meeting all maternal safe discharge checklist criteria

Percent of Opioid Exposed Newborns (OEN) rooming in with mother at any time during stay

Percent of OEN receiving any mother's milk at newborn discharge

Percent of OEN who go home to biological mother
